

DRR - CUSTOMER - LIMITED WARRANTY FOR ATV

DRR Inc. (hereinafter called Party A) gives the following Limited warranty to the buyer first purchaser (hereinafter called Party B) for DRR ATVS products.

Party A warrants to repair or replace the products are under normal use and maintenance, from any defects in material and workmanship. If any such defects should be found in products within applicable warranty period, Party A shall, at its option, repair or replace the parts as specified herein.

This warranty shall not apply to:

- (a.) Any defects caused by or repairs that are the result of abusive operation, negligence, accident, improper installation (modification) or inappropriate use as outlined in the owner's manual.
- (b.) Any products tampered with, modified, adjusted or repaired by any unauthorized party.
- (c.) Damage caused by repairs as a result of the use non-OEM items, for example, oil or tools not specified or approved by party A, including but not limited inappropriate tools.
- (d.) Any additional accessory installed by owner which cause damage to original parts.
- (e.) Any cosmetic damage to the surface or exterior of a product
- (f.) Any damage caused by external or environmental conditions, e.g., collision, fire, weather, falling objects, roll-over, mis use dealer improper set up IE: Melted plastic from failure to assemble correctly ETC..
- (g.) Any product presented without appropriate model and frame serial number identification.
- (h.) Any service is not furnished by a DRR authorized dealer.
- (i.) Any product used for rental, racing, leasing, demonstration or commercial purposes.
- (j.) Any product that has not been maintained according the part's maintenance schedule
- (k.) Any product for which the properly signed *Pre-delivery Checklist* and *Customer Safety and Warranty Checklist* and this *DRR - Customer-Limited Warranty for ATV* are not delivered to DRR Inc. within 7 days of purchase.

Warrantied parts and duration of warranties are:

- (a) Engine parts: 90 days parts only. 45 days for labor per DRR Inc. labor guide.
 - (b) Electrical components: 90 days parts only. 45 days for labor per DRR Inc. labor guide.
- Consumables such as battery, rubber, spark plug, belt, clutch, air cleaner, brake pad/lining, chain, sprockets, bulbs, body, frame, and shocks. The preceding does not constitute a complete list of consumables.

The Customer's responsibility under this warranty shall be to:

- (a) Operate and maintain the vehicles as specified in the Owner's Manual.
- (b) Give notice to authorized dealer of any and all apparent defects within (5) days after discovery, and make the product available at that time for inspection and repairs at such dealer's place of business.

All parts covered by this warranty and, within the warranty period, found to be defective will be repaired or replaced by our Authorized Dealer. See posted Dealers warranty for specific information in regards to labor coverage. Your Authorized Dealer is the only source for scheduled maintenance.

If warranty repairs are needed, the Authorized Dealer you choose to do the work must ask you for purchase and maintenance documentation consisting of the following:

- (a) Original repair orders or other receipts for required maintenance. These must show the dates of service,
- (b) Original purchase paper work.

DRR INC. MAKES NO OTHER WARRANTY OF ANY KIND. EXPRESSED OR IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE THAT EXCEED THE OBLIGATIONS AND TIME LIMITS STATED IN THIS WARRANTY ARE HEREBY DISCLAIMED BY DRR INC. AND EXCLUDED FROM THIS WARRANTY. SOME STATES DO NOT ALLOW LIMITATIONS AS TO HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATIONS OR THE FOLLOWING EXCLUSIONS MAY NOT APPLY TO YOU. ALSO EXCLUDED FROM THE WARRANTY ARE INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING LOSS OF USE.
